

## Aker Solutions Formalized Invoice Requirements

Aker Solutions has a set of invoice requirements that must be followed by our suppliers to avoid delayed payments. The latest version of these invoice requirements can always be found on our corporate website: <https://akersolutions.com/invoice-requirements>

If these requirements are not fulfilled, the invoice will be returned due to the missing details, and no payment will be made until a corrected invoice is received.

### Requirements

All invoices **must** contain following information:

- 1) Correct legal company name and invoice address. Please find overview in attachment
- 2) Reference person in Aker Solutions, identified by SAP Employee ID number 6 digits and name, or Aker Solutions issued Purchase Order(PO). For efficient invoice handling, PO number starting with 45 or 48, or Our Ref starting with 43 should be quoted
- 3) Other information
  - a) Supplier bank details
  - b) Invoice date and invoice number
  - c) Due date
  - d) Net amount, VAT amount and total amount
  - e) Invoice currency
  - f) VAT no. / organization number if applicable
- 4) Invoice content needs to mirror the PO information to facilitate compliant accounting
- 5) All invoices and supporting documentation (company letters, email text, attachments etc.) are preferably to be issued in English
- 6) Any other relevant information, e.g., project numbers, WBS code, other cost object information.

## Invoice Formats

All invoices must be sent in one of the following formats. We encourage our suppliers to make use of e-invoicing (EHF/E2B).

### 1. e-invoicing

Our EHF/E2B service provider is Pagero. Please visit this page for more information on [how to start sending e-invoices to Aker Solutions](#). The page also contains a list of companies which can receive e-invoices.

Vendors opting on e-invoicing should:

- E-invoicing is the preferred solution for all types of invoices
- For PO related invoicing, please only include one PO per invoice
- Mention the PO numbers, and/or including 'Our ref number' starting with 43,45 or 48
- Pay attention to the "Our ref" field versus "Your ref" field in order to get this correct
- Reference person in Aker Solutions should be identified by SAP Employee ID number 6 digits and name
- Total size should not exceed 50 MB, if so, please contact queries at [queries@akersolutions.com](mailto:queries@akersolutions.com) for guidance

The EHF invoice must include the required information, including all supporting documents, to provide an efficient approval process.

### 2. Email

Send the invoice with the required invoice information in a readable PDF file to [invoice@akersolutions.com](mailto:invoice@akersolutions.com)

- Only one invoice per email
- It should be one readable PDF file per invoice, including all supporting documents.
- Total size of the PDF should not exceed 10 MB
- No more than 20 pages in one PDF file
- The first page should be the invoice page and it should be rotated correctly.
- Page number should be in "1/1" format and our preferred invoice date format is DD/MM/YYYY
- If there are a variety of document types, they must all be converted to PDF format before sending.

Invoices must be submitted to Aker Solutions without undue delay and received by Aker Solutions no later than 10 working days after issue date. Invoices received past this date will be returned to the supplier for a revised invoice.
